"Normal use" constitutes abrasions and scratches to canoe/kayak and paddles, abrasions and scratches on wet suits, dirt on wetsuits, and PFDs. Tears, holes, and burns in canoe, wet suits, PFDs does not constitute normal wear. Adjustments to equipment damage may be made at the discretion of the renter. I will not hold liable the Releasees for any loss or damage to person or property incurred while travelling to the location of the rental, before, during, or after the rental period, and declare that this release is binding on me, my heirs, executors, administrators and assigns. I understand that in case of persons under 18 years of age, this application shall be signed on their behalf by a parent or guardian who thereby assumes all risks and responsibilities for any loss or injury to the child.

I understand that if I have to be evacuated, I am responsible for the costs incurred. Finally, I understand that the Releasees must reserve the right to withdraw or refuse any service to any applicant at any time.
